

## 1. Introduction

- These Terms and Conditions ("Terms") apply to the purchase and use of personal training bundles ("Bundle") provided by Aesthetic Athletics ("we," "us," or "our").
- By purchasing a Bundle, you ("Customer" or "you") agree to comply with these Terms.

## 2. Bundle Purchase and Payment

- The Bundle includes personal training sessions at the total price when purchased.
- Payment for the Bundle is required in full at the time of purchase.

## 3. Scheduling and Use of Sessions

- The Bundle is valid until all sessions are completed from the date of purchase. Unused sessions after this period will be forfeited.
- Sessions are subject to availability and must be used within the validity period. We recommend booking early to secure your preferred times.
- Sessions can be used in-person, online, or a combination of both, depending on your preference and availability of trainers.

## 4. Cancellations and Rescheduling

- You may reschedule a session with at least 24 hours notice. Sessions cancelled with less notice may be forfeited at our discretion.
- We reserve the right to cancel or reschedule sessions due to unforeseen circumstances, such as trainer unavailability. In such cases, you will be offered an alternative time, trainer or session credit.
- You may cancel your subscription within 60 days of purchasing.

## 5. Expiry and Extension

- Extensions may be granted for medical reasons or other extenuating circumstances with appropriate documentation and at our discretion.

## 6. Trainer Assignments

- We strive to match you with the same trainer throughout your Bundle; however, this is not guaranteed.

- If your assigned trainer becomes unavailable, we will arrange for another qualified trainer to continue your sessions.

- You agree to provide accurate and up-to-date information during the registration process.
- You must be at least 18 years old or have parental consent to purchase and use the Bundle.
